PP 20/113 Application 4/20/2182/0F1 - Land at The Millway, Devonshire Road, Millom

The application for the redevelopment and extension of the Millway building for restaurant, kitchen, café/restaurant, reception area; erection of octagon community assembly building; 13 no. residential units (including 4 no. accessible units); 4 no. vardo wagons, 12 airstream caravans; 2 ancillary toilet blocks; sculptures; warehouse; associated parking and infrastructure with ancillary facilities, was presented by the Planning Officer.

A vote was then taken, by way of a roll call.

- The addition of a new Condition regarding the Café/Restaurant fit out due to extraction requirements, etc.
- Updating the documents and plans list relating to Condition 2.
