In order to comply with the Parish/Town Council's Code of Conduct, a Member or Co-opted Member (M) must register their pecuniary and interests other than pecuniary interests with the District Council's Monitoring Officer within 28 days of the date of their election or co-option. *(Failure to declare a disclosable pecuniary interest is a criminal offence).*

Note – A Member must, within 28 days of becoming aware of any new interest or change to any interest specified above, register details of that new interest or change by completing a new Register of Interest Form and submitting it to the Council's Monitoring Officer.
