**Localism Act 2011, Sections 28 & 29
The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012**

In order to comply with the Parish/ Town Council's Code of Conduct, a Member or Co-opted Member must register their pecuniary and interests other than pecuniary interests with the Borough Council's Monitoring Officer within **28 days** of the date of their election or co-option. (*Failure to declare a disclosable pecuniary interest is a criminal offence*).

Note – A Member must, within 28 days of becoming aware of any new personal interest or change to any personal interest specified above, register details of that new personal interest or change by completing a new Register of Interest Form and submitting it to the Borough Council's Monitoring Officer.

Important Notes – You may complete this form electronically but you must personally sign the completed form.

If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.
